Descriptions of Workshops and Local Site Visits

Thursday March 18th

Workshop 9:30 – 4:15 Creating Reliable Fundraising in Unreliable Times - Kim Klein

Land Trusts and other conservation or stewardship organizations need dependable strategies for fundraising, which can grow quickly, use the wonderful talent of volunteers, and survive a roller coaster economy. In this fast paced practical workshop, Kim Klein will take you through how to set up, maintain and expand a systematic fundraising program that is predictable and manageable, how to identify prospects and ask for large amounts of money in person, and how to find new donors and keep them giving year in and year out without spending a fortune. You will learn how to segment your donor list so that you give donors the attention they want, how to structure your fundraising campaigns so that you are constantly building a fundraising team, and how to think long term while acting effectively in the moment. Kim Klein has worked with Land trusts in the USA and Canada and will speak specifically to your challenges.

Site Visit A - 12:30 – 4:00 apx Meet at parking area Smythe Road, Penticton

Skaha Bluffs/Sublot 18 This was a major partnership acquisition project that spanned several years and involved the NCC, MoE, TLC, TNT, The Climbers' Access Society of B.C. Penticton-area Climbers, MEC, and a host of wildlife conservation organizations/agencies such as the Wild Sheep Foundation and the Habitat Conservation Trust Foundation. Commonly referred to as the Skaha Conservation Area, it is an important recreation land and provides critical habitat for bighorn sheep and other species at risk. This site is located just south of Penticton, approximately 25 minutes from Naramata. There are some spectacular views from this 304 ha. property. The access road does not normally open up until April, so participants will be required to walk approximately 1.5 kl. on the access road to the main hub/parking area. From here, a short circle hike on a foot trail will lead into the main bluffs area, where the terrain is slightly rugged and there will be lingering snowpack, so a sturdy (over the ankle) hiking boot/shoe is recommended, plus drinking water as needed. Participants should ensure they wear light colored clothing to avoid ticks. Total distance hiked on this site visit will be approximately 6.5 kl. (round trip).

Site Visit B – 12:30 – 4:00 apx. Meet at Osoyoos (TBD)

Join the First Nation's Land Trust for a site visit to Osoyoos Indian Reserve near Osoyoos The site is approximately 45 minutes from Naramata and will be joined with another visit to a restoration project on the way from Osoyoos toward Naramata. The tour would include several parcels of land that are being sought for protection as well as a visit to the Nk'mip Cultural Centre at Spirit Ridge in Osoyoos, expanded by a short hike to protected desert lands also in an almost pristine state. The tour will show specific parcels of extremely valuable lands ripe for protection or acquisition. The specific habitats are desert to grasslands and riparian habitat in a virtually untouched environment.

Okanagan River Restoration Initiative (ORRI)

During the 1950s much of the Okanagan River was straightened, narrowed and dyked to control flooding. This, and development adjacent to the river resulted in the loss of approximately 90% of important aquatic and riparian habitats. During 2009, the Ministry of Environment, the Okanagan Nation Alliance and partners directed the completion of Phase 1 of ORRI, reconnecting the river channel to a historic floodplain and oxbows along 600 meters of Okanagan River north of Oliver, providing huge benefits for aquatic and riparian species, including sockeye and Chinook salmon, rainbow trout, and several endangered wildlife species. Restoration of disturbed areas began. Planting of native vegetation will significantly contribute to the long term success of the project and provides benefits to the many residents and visitors who utilize the new hiking/biking path.

Site Visit C: - 10:30 – 2:00 Meet at Naramata Centre

TLC's South Okanagan-Similkameen Stewardship Program supports private landowners in conservation of natural areas.
